SUBJECT: Department of Army Guidance to Address Perfluorooctane Sulfonate and Perfluorooctanoic Acid Contamination

1. References:

b. Memorandum, OASD (EI&E), 10 Jun 16, subject: Testing DoD Drinking Water for Perfluorooctane Sulfonate (PFOS) and Perfluorooctanoic Acid (PFOA).

2. This memorandum provides guidance for implementing the policies identified in reference 1a and 1b.

3. Background: The Army is committed to providing safe drinking water (OW) to all Soldiers, Families, and Civilians receiving OW on Army installations or facilities. The enclosed guidance identifies the required sampling actions to determine whether OW systems have PFOS/PFOA concentrations exceeding health based standards and assess whether restoration cleanup sites have adequately investigated possible PFOS/PFOA contamination associated with past Army activities. When evaluating PFOS/PFOA results, the Army will use the Environmental Protection Agency lifetime health advisory of 70 parts per trillion or 0.07 j.Jg/1 for both the individual PFOS or PFOA concentration.
