- US EPA is responsible for corrective action activities and decisions at Fort McCoy under the 1990 permit. The proposed permit modification is a US EPA draft decision in which WDNR does not have a direct role. However, WDNR has reviewed and provided comments on all corrective action documents from the start of the corrective action process. WDNR has independently made decisions under State authority on the completion of monitoring at units subject to corrective action at the facility.

Does this pending decision have any relevance to the PFAS contamination that has been identified at Fort McCoy? If none, who is the EPA point of contact for PFAS contamination at Fort McCoy? (see attached)

- The PFAS investigations are not related to corrective action conditions in the 1990 federal permit. They are included in the Statement of Basis for informational purposes only, contributing to a more complete contaminant history. The WDNR is overseeing the PFAS investigations (working with the Department of Defense) under Section 292.11 of the Wisconsin Statutes. Mae Willkom is the WDNR contact.

Does the pending decision have any relevance to open burning/open detonation activities at Fort McCoy?

- No, the corrective action conditions in the federal permit for the Fort do not address open burning/open detonation activities.

Answers to each of your questions are as follows:

1. Yes, the MOA you cite is current.
2. The types of sites to which the MOA is applicable (including CERCLA), as well as limitations on that applicability, are discussed in detail in Section 1.B of the MOA itself.
3. Section II.B. of the MOA provides a list of the applicable states statutes and administrative codes. Although it applies to many cleanup sites handled by the DNR Remediation and Redevelopment program, it does not apply to the Clean Water Act, the Safe Drinking Water Act and other federal law implementation in Wisconsin. For information on how it applies to the Toxic Substances Control Act (specifically PCBs), please refer to Publication RR-786 at <https://dnr.wi.gov/files/PDF/pubs/rr/RR786.pdf>.

Hi Mae,

Thank you for your email. From your reply, I'm wondering if you saw the communication that I forwarded to you from EPA so I'm sending again (copied below). Yes, I saw EPA's reply. According to the Statement of Basis, EPA is proposing to close the three burn pits at Fort McCoy and further that post-closure, the PFAS contamination at and near all three pits will be managed by the WDNR. It would be more accurate to say that the Statement of Basis is proposing to close the federally-permitted RCRA Corrective Action activities at Fort McCoy, including FTBP1 and FTBP2; FTPB3 was not part of the permit. I would like to know if WDNR concurs with this proposal and how both agencies will manage this transition and the subsequent potential implications or conflicts that may arise. For example, if EPA authorizes abandonment of groundwater monitoring wells (installed to track VOCs etc.) and WDNR would like to retain these wells for monitoring PFAS, how will this be managed? If EPA authorizes a cap as part of site closure (for VOCs, etc) and later

WDNR determine that it would like soil samples for PFAS, how will that work? Yes, WDNR concurs with this proposal. A "One Cleanup" Memorandum of Agreement with EPA fully authorizes WDNR to lead cleanups and removes confusion of varying program requirements. EPA and WDNR work together to reach consensus when necessary (EPA is copied on this response.) Responsible party letters have already been issued requiring PFAS site investigations for all three burn pits. In addition, the May 24, 2018 final closure letter for VOC cleanup at FTBP1 states that groundwater monitoring wells will be left in place for use in conducting a separate PFAS investigation. If necessary, WDNR could grant approval for disturbance of an existing cap for additional environmental sampling.

In a related matter, DOD officials recently testified before Congress that they will "consider" but may not comply with State Standards for PFAS at military sites like Fort McCoy (see attached). Unlike some states, Wisconsin has a relatively broad definition of "hazardous substance" under which PFAS are included. Chapter 292.11 of the Wisconsin Statutes gives WDNR very clear authority to require investigation and remediation of a hazardous substance discharge.

I don't really need to see the WDNR's written comments but I would like to speak with someone there at WDNR while there is still an opportunity for me to incorporate in public comment to EPA, if indeed necessary. If you are not sure if you can speak with me, please direct me to someone who may. If necessary, I may refer you to others for questions which are not site-specific. If staff in your section are not allowed to speak with the interested public, I will accept an email reply.

- US EPA is responsible for corrective action activities and decisions at Fort McCoy under the 1990 permit. The proposed permit modification is a US EPA draft decision in which WDNR does not have a direct role. However, WDNR has reviewed and provided comments on all corrective action documents from the start of the corrective action process. WDNR has independently made decisions under State authority on the completion of monitoring at units subject to corrective action at the facility.

Does this pending decision have any relevance to the PFAS contamination that has been identified at Fort McCoy? If none, who is the EPA point of contact for PFAS contamination at Fort McCoy? (see attached)

- The PFAS investigations are not related to corrective action conditions in the 1990 federal permit. They are included in the Statement of Basis for informational purposes only, contributing to a more complete contaminant history. The WDNR is overseeing the PFAS investigations (working with the Department of Defense) under Section 292.11 of the Wisconsin Statutes. Mae Willkom is the WDNR contact.

Does the pending decision have any relevance to open burning/open detonation activities at Fort McCoy?

- No, the corrective action conditions in the federal permit for the Fort do not address open burning/open detonation activities.

Below is an excerpt from an internal guidance document (intended for internal DNR staff use only) which covers, in part, the confidentiality of Superfund documents. Although the Fort McCoy federal RCRA permit has nothing to do with the NPL, it was this guidance that made me question whether confidentiality guidelines for a draft federal RCRA Corrective Action permit modification might be somewhat similar.

2. Superfund Documents

All DRAFT documents prepared by EPA, their contractors, DNR or DNR contractors related to work being done on sites that are already on the National Priorities List (NPL) are confidential. Once the documents are finalized or the cleanup is completed, these documents are no longer confidential.

Note: All documents, including drafts, prepared by Potentially Responsible Parties or their consultants are not normally considered confidential.
